



**OFFICIAL RULES
MAY 2016 CHARITY HAND-UP CONTEST
VOTER PRIZE DRAWING**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE CITYWIDE BANKS CHARITY HAND-UP CONTEST VOTER PRIZE DRAWING (“Sweepstakes”).

VOID WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL REGULATIONS. A PURCHASE, BANK ACCOUNT, OR BANK TRANSACTION WILL NOT IMPROVE YOUR CHANCE OF WINNING.

TO ENTER: The Sweepstakes begins at 9:00 a.m. MDT on May 2, 2016 and ends at 11:59 p.m. MDT May 22, 2016 (the “Entry Period”), and coincides with the voting period for the Citywide Banks Charity Hand-Up Contest program. All times in these Official Rules refer to Mountain Time. An individual can enter the Sweepstakes, as well as cast their vote for a charity nominee, in one of the two following ways:

- (1) An individual will be entered if they go to Citywide Banks Facebook® Page at [Facebook.com/citywidebanks](https://www.facebook.com/citywidebanks), click on link to “Charity Contest,” and complete the online voting form contained on such page. Complete name, contact information, age verification, and charity selection fields on the online voting form. Submit form by clicking the CAST VOTE button at bottom of voting form. An individual must either have or create a Facebook® account in order to vote and submit their entry via such page. An individual may vote for a charity nominee without submitting the additional information necessary to enter the Sweepstakes, but a valid automatic entry will not be made unless user selects one of the seven nominated charities and submits all required additional information as provided on the online form.
- (2) Alternatively, an individual may enter the Sweepstakes by handwriting their choice of one of the seven nominated charities in current contest, plus their first name, last name, date of birth, address, city, state, zip, phone number, and the words “Charity Hand-Up Contest Voter Prize Drawing,” on a 3”x 5” card and mailing it in a business size (#10) envelope, first class postage prepaid, to Citywide Banks Marketing Department, 13741 E. Mississippi Avenue, Suite 102, Aurora, CO, 80012. Mail-in entries must be postmarked no later than May 19, 2016 and must be received no later than May 23, 2016.

Entries are limited to **one per person/Facebook account for online entry, or one per household** if using mail-in entry method. Duplicate entries through both channels are not permitted. All entry information must be complete and accurate. Odds of winning a prize are dependent upon the number of entries received. Citywide Banks is not responsible for lost, late, damaged, incomplete, illegible, or misdirected entries. **Information obtained through entries will be provided only to the Sponsor and those service providers engaged by the Sponsor to assist it in connection with the Sweepstakes, and not to Facebook, will only be used for the purposes of the Sweepstakes, and will not be shared with or sold to any other third parties.**

ELIGIBILITY: An entrant does NOT have to be a customer of Citywide Banks in order to be eligible to enter the Sweepstakes, and a purchase, bank account, or bank transaction will not improve an entrant’s chances of winning. The Sweepstakes is only open to U.S. residents who are at least 18 years of age at the time of entry. Employees of Citywide Banks (the “Sponsor”), its affiliates and subsidiaries, and its paid consultants, affiliated companies, and suppliers, and their immediate family members, are not eligible. Void where

prohibited, taxed or otherwise restricted by law. The Sponsor is solely responsible for all aspects of the promotion. The term "immediate family" includes parents, children, spouses, siblings, and in-laws, whether or not they reside in the same household. DRAWING: On or about May 23, 2016, prize winners will be selected via a random drawing from among all eligible entries received. Winners will be notified via email, phone, and/or mail on or about May 31, 2016.

There will be two (2) First Prize winners and ten (10) Second Prize winners. Winners in each category will be randomly chosen from eligible entries received.

PRIZES: Prizes and their estimated retail value are as follows:

- **(2) First Prize** – \$100 Gift Certificate to Guard & Grace restaurant (\$100 value)
- **(10) Second Prize** – \$10 Starbucks Gift Certificate (\$10 value)

There will be no substitutions for prizes. If for any reason a prize as offered becomes unavailable, an alternate prize of equal or greater value will be awarded.
